the Institute that approval is by the Central Agency is of no assistance. Definition of "Professional Education' in section 2(r) and 'Appropriate Authority' in section 2(b) of Act, 2015 takes care of this".

- 4. Once it is established that the Institute is based in the State of Maharashtra and is: (a) Self-financed; (b) Private; (c) conducts Professional course, as declared by Government and (d) such course is affiliated to any University, Provisions of Act, 2015 are attracted. Time and again the Institute was asked to submit fees proposal. There is no compliance till date. Now before this Authority no alternative is left except to take coercive steps according to Law.
- In view of the above, the Institute shall keep their representative present before this Authority on 23/1/2020 to show cause / explain as to why penalty according to law be not imposed on them. Further non submission of fees proposal will entail consequence of this Authority fixing fee structure, as may deem appropriate.


